**Re: Tres Palacios Gas Storage LLC - Penalty Disbursement Report**  
**Docket No. RP22-\_\_\_\_\_**

Dear Secretary Bose:

In accordance with Sections 6.5 and 6.32 of the General Terms and Conditions (“GTC”) of the Tres Palacios Gas Storage LLC (“Tres Palacios”) FERC Gas Tariff, First Revised Vol. 1 (“Tariff”), Tres Palacios hereby submits its penalty disbursement report for the twelve (12) month period from August 1, 2021 to July 31, 2022.

Pursuant to its Tariff, Tres Palacios is required to file with the Commission a penalty disbursement report within sixty days of July 31 or sixty days after the end of the Month for which revenue collected exceeds \$1,000,000.

Specifically, Tres Palacios is required to disburse the following penalty revenues to non-offending shippers on a pro-rata basis:

- (1) pursuant to Section 6.5 of the Tariff, Tres Palacios is required to disburse penalty revenues arising from quantities tendered and / or taken by a Customer(s) in violation of an Action Alert or Operational Flow Order), and
- (2) pursuant to Section 6.32 of the Tariff, Tres Palacios is required to disburse penalty revenues arising from any Customer(s) Gas remaining in the storage facility upon the expiration or termination of a service agreement.

Tres Palacios hereby confirms that, during the twelve-month period ended July 31, 2022, it did not assess, collect, or receive any penalty revenues.

Tres Palacios requests that the Commission accept this Penalty Disbursement Report consistent with GTC Sections 6.5 and 6.32 of its Tariff, and requests that the Commission grant any waivers that it may find necessary to accept this Penalty Disbursement Refund Report for the specified period.


The undersigned has read this filing and knows its contents; the contents are true as stated, to the best of the undersigned’s knowledge and belief, and the undersigned possesses full power and authority to sign this filing.
